- 3) **HEREBY ACKNOWLEDGES THAT THE ACTIVITIES OF SAID EVENT ARE DANGEROUS AND INVOLVE THE RISK OF INJURY AND/OR DEATH AND/OR PROPERTY DAMAGE.**
- 4) **If, despite this release, I or anyone on my behalf makes a claim against the 'releases' named above, I agree to indemnify, save and hold harmless said releases FROM ANY LITIGATION, ATTORNEY FEES, LOSS, LIABILITY, DAMAGE OR COSTS they may incur due to said claim made against the releasees.**
